Terms & Conditions

DEPOSIT: A deposit of 25% of the total value of the trip is due and payable at the time of booking.

FINAL PAYMENT: Final payment is due 45 days prior to departure. Fishing Getaways reserves the right to charge a \$25.00 per person late fee. Excepting in circumstances when the booking is made within a 45 day time frame when the final payment is due at least 2 weeks prior to departure.

SERVICE FEE: Fishing Getaways reserves the right to charge a fee for services rendered, irrespective of any reason for cancellation of requirements.

AMENDMENTS: Fishing Getaways reserves the right to charge a \$25.00 fee for each alteration made to the original itinerary including any amendment charge incurred by our suppliers will be the liability of the client.

CANCELLATION: Prior to 45 days, cancellation will incur a 15% charge per person. Within 45 days of travel will incur a 30% charge per person plus any air or land cancellation fees that may apply. Cancellation within 7 days of departure will incur a 100% cancellation fee on land contents and applicable rate on airline tickets.

UNUSED SERVICES: Due to weather, transport delays, strikes and any other cause beyond the control of Fishing Getaways or it's tour/travel/resort/boat operators, our domestic and overseas representatives and airlines, there is a possibility of contracted services not being extended. Fishing Getaways will endeavour to secure refunds for the same, but will not be held responsible if funds are not forthcoming.

FISHING PACKAGES: Fishing Getaways will endeavour to rebook or rearrange fishing packages, arrange a refund on behalf of the client if in such a case the package was not able to be fulfilled due to circumstances beyond the control of Fishing Getaways Eg weather troubles. In the event of equipment breakdown, such as boat compressor failure, compensation will be made at the sole discretion of its tour/travel/resort/boat operator's management.

PRICES: Quotes are inclusive of service fee and GST. The service fee is not applicable for the cost of Domestic Fares, Hotels, Transfers, Tours etc. to be broken up.

TRAVEL INSURANCE: Wide ranges of travel insurance policies are available to guard against accident, missed or unused services or loss. We strongly suggest that all travellers take some form of travel insurance. Fishing Getaways however only acts as a sale agent and all claims and legalities must be dealt directly with the insurance company.

TRAVEL DOCUMENTS: Please check with your authorities for Passport, Visa, and Inoculation requirements.

AIRLINE SCHEDULES: Itineraries have been programmed as per current schedules. If flight schedule changes occur, it may be necessary to alter itineraries. Climatic conditions such as wind, rain, cyclonic weather, snow etc. may also necessitate sudden changes. The services of the stipulated airlines must be used on the international route. Increase in airfare can apply if other carriers are used.

RESPONSIBILITIES: Fishing Getaways and/or associated agents act only in the capacity of agents in all forms of transportation and tour operation and as such agents assume no liability for injuries, damage, losses and accidents incurred or changes in the itinerary beyond the agents control. Airlines concerned are not responsible for any acts, omissions or events while passengers are not aboard the aircraft. Tickets are sole contracts between airlines and passengers. The right is reserved by the agent to revise, omit or substitute and hotel, feature or change in the schedule as is deemed necessary.
